Declaration of Successful Nominations by the Returning Officer 13/8/2018

Announcing the nominees

This announcement is made in accordance with Section 19 of the new PARSA Constitution (the Constitution).

[1] Uncontested positions are elected unopposed as per the procedures described in Clauses 19.2 and 19.3 of the Constitution.

[2] Contested positions shall be determined by a ballot of members as described in Clause 19.4 of the Constitution. As previously announced polling will take place from the 27th until the 30th August. Information about polling and voting procedure will be released over the next two weeks.

[3] Positions where no nominations were received are declared as casual vacancies. These vacancies are to be filled by the PARSA Board as per Clause 16.6 for Directors of the Board and Clause 27.4 for Portfolio Officers, College Officers and the Vice President.

The validity of all nominations received has been checked against census data provided by ANU on the 13th August 2018 as required by Clause 4.6 of the Election Regulations. Eligibility requirements have been verified by the Returning Officer.
