Nomination Form

Complete this form if you wish to nominate for a position in the PARSA Annual General Election 2019. This form must be completed by the candidate wishing to nominate for a position/s in the Election and be signed by themselves along with a proposer and seconder.

Nomination forms must be lodged with the PARSA **Returning Officer** electronically via <u>parsa.elections@anu.edu.au</u> or handed into the PARSA office.

Candidate Profile statements

During the period that nominations are open, candidates are encouraged to send to the Returning Officer their **photograph** (square photo 290px x 290px in JPG or PNG format) and a **personal statement** (250-word maximum) in support of their nomination.

The Candidate Profile statement must be submitted in writing, but may also be provided as an audio or video statement; these will be included on the Election section of the PARSA website. The transcript of the audio or video statement should be the same as the Candidate Profile.

Nomination

In order to nominate for a position you (the candidate) must be an Ordinary Members of PARSA, except for the position of Postgraduate Student Member of the ANU University Council which only requires that you are a postgraduate student at ANU.

An Ordinary Member is defined by Section 3.2.1 of the Constitution as: a postgraduate or research student at the ANU who has not stated that the person does not wish to be a member pursuant to Section 7. All postgraduate and research students at the ANU are, by their University enrolment, automatically admitted as members of PARSA.

A candidate may **only stand in the Election for one** of the following positions (Clause 6.2 of the Election Regulations):

- 1. The PARSA President.
- 2. Four (4) Directors of the Board.
- 1. The position of Vice President.
- 2. Eleven (11) Portfolio Officers.
- 3. Two (2) College Officers (one Coursework and one Higher Degree by Research) from each of the seven (7) ANU Colleges.

A candidate may stand concurrently for and be elected to the position of Postgraduate Student Member of the ANU University Council.

Additional eligibility requirements are listed for some positions, these are found in the Election Regulations under Clause 5. Some positions also require disclosure of certain information by the candidate, their proposer and seconder.

Information about how these requirements will be managed is provided by the Returning Officer on the <u>Election Central section of the PARSA Website</u>. Nominees must comply with all requirements listed on the nomination form, in the Constitution and the Election Regulations.

A candidate must be nominated by at least two other people who are also eligible to nominate for the position(s) that the candidate is nominating for. Self-nomination is not permitted.
